DIRECTIONS TO THE TEST SITE:

From the CSCA National Hotel heading South: Take I-205 Southbound and merge onto I-5 South. Take exit 282A toward Canby/Hubbard. After about 1 mile Turn Right onto Arndt Rd NE. Continue for 3.5 miles and then turn Left onto 2nd St NE/Butteville Rd NE (Continue to follow Butteville Rd NE). In .05 miles turn Right onto Champoeg Rd NE, and your destination will be on the left.

From the South heading North: Take Exit 278 off of I-5 North approximately 20 miles North of Salem. Turn Left onto Ehlen Rd NE/Fargo Rd NE from the off-ramp. Go 2.6 miles and continue onto Yergen Rd NE for one mile. Turn Right onto Case Rd NE. In 1.3 miles turn Left onto Champoeg Rd NE. Champoeg Park will be about one mile down the road.

General information and test rules

1. Entry Fee is: \$75.00 payable in US dollars. Entry fee includes a \$.50 AKC recording fee and \$3.00 event fee. Make checks payable to CSCA.
2. Closing date for entries will be will be accepted until 5:00 PM, Friday March 23, 2018 after which time entries will not be accepted, canceled, altered or substituted.
3. For other delivery options call or email the test secretary for instructions. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
4. A random drawing will take place Friday March 23, 2018 at 6:00 PM, at 17490 Gardner Road, Dallas OR 97338. The drawing will determine which entrants will participate. The drawing will be random among those entries received, and per AKC rules, preference in draw order is as follows: Specialty breed w/out

title, Specialty breed with title, other entries w/out title, other entries with title. All persons submitting entries are invited to attend the drawing. The Test Secretary will notify all entrants of the results of the draw by Email.

5. Mail all entries of dogs that have not earned a TD title, with an original written statement of certification dated within one year of the date of the test signed by an approved or provisional tracking judge, with entry and fee to: Sarah Beard, 17490 Gardner Road, Dallas OR 97338. Make checks or money orders payable to CSCA.
6. Only one entry per dog will be accepted. Dogs not holding any tracking dog title will have priority for the draw. Please do not mail additional entries. They will be returned. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
7. Acknowledgement of entries will be made as soon as possible after the drawing. If the exhibitor does not receive acknowledgement within a reasonable time, please email sarah@peppadew.farm or call 503-999-9663
8. All dogs and handlers must be at the Tracking Test Area before 7:00 AM on Monday April 2nd, at which time there will be a drawing for track order. Entrants not present at the time of drawing for tracks may be marked absent and an alternate allowed to run in their place.
9. An alternate list will be maintained for the TD Test. No entry fees will be refunded unless an alternate is present and runs on the absent dog's track. Entry fees of an alternate that does not compete shall be refunded. In the event an accepted entry is absent on the day of the test, the Tracking Test Secretary shall determine if any alternates are present, and the available track shall be assigned in the order in which alternate entries were drawn.
10. Judging will start as soon as the first track has aged the required time.
11. The entry fee will be refunded if either 1) entrant notifies test secretary prior to the draw 2) the entrant notifies the secretary prior to the test and an alternate runs the track, or 3) the dog is an alternate who does not run a track.
12. BITCHES IN SEASON MAY PARTICIPATE under the conditions specified in the AKC Tracking Regulations.
13. The AKC believes the well-being of dogs and participants are of paramount importance. In the case of adverse weather conditions, the test could be canceled and rescheduled.
14. All entrants are responsible for complying with the AKC rules regarding Tracking Tests and other AKC rules referred to in the Tracking Test Rule book.

- (Variety) if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in. over 13 in. but not exceeding 15 in.) , Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rules refer to Chapter 11, Section 3.)
- Mixed breed dogs entering classes for Agility, Obedience and Rally trials should mark breed as "All-American Dog/ Mixed Breed". Sire and Dam information shall remain blank for mixed breed entrants.
